

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-593, "Approving Chukut Kuk District FY 2005 Budget
and Justification" to include New Fields and Ston Sudagi)**

RESOLUTION NO. 04-664

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 04-593, did approve**
2 **Chukut Kuk District FY 2005 budget in the amount of \$1,039,039.25 retroactive to**
3 **October 01, 2004; and**

4 **WHEREAS, before funds are disbursed, community budgets will be forwarded to the Chukut Kuk**
5 **District office; and**

6 **WHEREAS, eight of the ten communities did submit their budgets with justifications to the**
7 **Chukut Kuk District office; and**

8 **WHEREAS, the communities of New Fields and Ston Sudagi did also submit their budgets with**
9 **justifications to the Chukut Kuk District office.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**
11 **Resolution No. 04-593 to include the communities of New Fields and Ston Sudagi.**

12 **BE IT FINALLY RESOLVED that the New Fields and Ston Sudagi Communities are hereby authorized**
13 **to expend community funds in accordance to the budget submitted to the Tohono**
14 **O'odham Legislative Council and incorporated into the Chukut Kuk District FY 05**
15 **Budget and justification.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
17 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
