

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of DeConcini McDonald Yetwin & Lacy)

RESOLUTION NO. 04-668

1 **WHEREAS, pursuant to Resolution No. 03-551, the Tohono O'odham Nation (the "Nation") entered**
2 **into an Attorney Contract with the law firm of DeConcini McDonald Yetwin & Lacy (the**
3 **"Attorneys") to provide legal representation to the Nation related to the Project for**
4 **fiscal year 2004; and**

5 **WHEREAS, the Attorney Contract expired on September 30, 2004; and**

6 **WHEREAS, the Cultural Affairs Program requires continuing legal representation related to**
7 **negotiation of a construction contract and such other matters as may be assigned by**
8 **the Attorney General with the concurrence of the Project Administrator; and**

9 **WHEREAS, the Cultural Affairs Program recommends the engagement of the Attorneys for the**
10 **forgoing legal services; and**

11 **WHEREAS, attached hereto is an Attorney Contract with the Attorneys in the amount of \$15,000**
12 **for fiscal year 2005; and**

13 **WHEREAS, the Cultural Preservation, Domestic Affairs and Budget & Finance Committees**
14 **recommend approval of the Attorney Contract.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
17 **with the law firm of DeConcini McDonald Yetwin & Lacy in the amount of \$15,000**
18 **for fiscal year 2005 and in the form attached hereto.**
- 19 **2. Funding of the Attorney Contract shall be provided from the Cultural**
20 **Affairs/Museum Budget (Account No. 50-1516-810).**
- 21 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
22 **Contract.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
24 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,454.3 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 175.4 [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
