8		1982 ("SAWRSA"), the Tohono O'odham Nation (the "Nation") received \$15,000,000.00				
9		to be held in trust by the Nation (the "SAWRSA Trust Fund"); and				
10	WHEREAS,	under Section 309 (b) of SAWRSA, the Nation may expend accrued interest and				
11		dividends on the SAWRSA Trust Fund "for the subjugation of land, development of				
12		water resources, and the construction, operation, maintenance, and the replacement				
13		of related facilities on the Papago Reservation (now known as the Tohono O'odham				
14		Reservation) which are not the obligation of the United States under this (SAWRSA) or				
15		any other Act of Congress"; and				
16	WHEREAS,	the San Xavier Cooperative Association has agreed to pay for the yearly maintenance				
17		costs of the equipment and requests that the Nation pay for the yearly insurance				
18		costs; and				
19	WHEREAS,	theresponsibilitiesoftheSanXavierCooperativeAssociationEquipmentInsurance				
20		Budget qualify for the funding under the SAWRSA Trust Fund; and				
21	WHEREAS,	the San Xavier Cooperative Association has prepared the attached budget for Fiscal				
22		Year 2005 in the amount of \$5,588.00 and funded from the SAWRSA Trust Fund.				
23	NOW, THEREFORE, BE IT RESOLVED THAT:
