(Authorizing the San Xavier District to Submit an ICDBG Proposal in the amount
of \$1,031,160.00 to HUD, and to Administer the Grant Program if Awarded)**

RESOLUTION NO. 04-681

- 1 **WHEREAS, the Tohono O'odham Nation and the Tohono O'odham Legislative Council support**
2 **Districts in their efforts to improve quality of life for their communities and**
3 **members; and**
- 4 **WHEREAS, efforts to improve quality of life in any one District are beneficial for the Nation as a**
5 **whole; and**
- 6 **WHEREAS, the Department of Housing and Urban Development (HUD) offers money for housing**
7 **rehabilitation under its Indian Community Development Block Grant (ICDBG)**
8 **program; and**
- 9 **WHEREAS, the San Xavier Housing Department has a waiting list of community homes that are**
10 **substandard and in need of rehabilitation; and**
- 11 **WHEREAS, neither the Tohono O'odham Nation nor the Ki:Ki Association is applying to the**
12 **ICDBG this year; and**
- 13 **WHEREAS, San Xavier is eligible for ICDBG monies, as a P.L. 93-638 Title I eligible entity,**
14 **provided a concurring resolution is obtained from the Tohono O'odham Legislative**
15 **Council; and**
- 16 **WHEREAS, the San Xavier Housing Department has the capacity to implement an ICDBG**
17 **program, and the District's Grants Manager and Finance Department have the**
18 **capacity to administer this award; and**
- 19 **WHEREAS, the San Xavier District Council, at a special meeting on November 30, 2004, approved**
20 **submission of this grant and requested a concurring resolution from the Tohono**
21 **O'odham Legislative Council; and**
- 22 **WHEREAS, at its public meeting on December 09, 2004, the Tohono O'odham Legislative Council**
23 **reviewed and discussed the grant packet.**
- 24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
25 **San Xavier District to submit their ICDBG proposal in the amount of \$1,031,160.00**
26 **and administer any funds awarded.**
- 27 **BE IT FINALLY RESOLVED that the San Xavier District will assume full responsibility for the grant**
28 **if awarded and releases the Tohono O'odham Nation from**
29 **any liability.**




