

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Baboquivari District Administration and Communities FY 2005 Budgets)**

**RESOLUTION NO. 04-683**

1 **WHEREAS, the Baboquivari District Council did approve the gaming distribution in the amount**  
2 **of \$1,419,643.73 to be divided among the six (6) communities and the District**  
3 **Administration, with 40% allocated to the district administration and 60% to be**  
4 **divided among the Baboquivari District communities; and**

5 **WHEREAS, on November 30, 2004, the Baboquivari District Council did meet with the eleven (11)**  
6 **community representatives and did approve the FY-2005 Baboquivari District**  
7 **Administration budget and community budgets; and**

8 **WHEREAS, the following distribution will be allocated to administration and the Communities:**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
18 **the Baboquivari District FY 2005 Budget in the amount of \$1,419,643.73 to be**  
19 **distributed with 40% in the amount of \$567,857.51 to Baboquivari District**  
20 **Administration and 60% in the amount of \$851,786.22 to be divided among the six (6)**  
21 **communities @ \$141,964.37.**

22 **BE IT FURTHER RESOLVED that the Baboquivari District FY 05 Budget be retroactive from October**  
23 **1, 2004.**

24 **BE IT FINALLY RESOLVED that the amount of \$1,419,643.73 be allocated from the FY 05 Gaming**  
25 **Distribution.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>, Day**  
27 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
