1	WHEREAS,	effective June 16, 2004, the Tohono O'odham Nation (the "Nation") entered into an
2		Architect Agreement with Gresham & Beach Architects, Inc. (the "Architects") to
3		provide services related to the Dialysis Clinic (the "Project"), including design,
4		$bidding, preparation\ of\ construction\ documents, and\ construction\ administration;$
5		and
6	WHEREAS,	attached hereto is a Construction Management Contract between the Nation and
7		ChuskaSahara, LLC, the successful bidder (the "Construction Manager"), for pre-
8		construction services related to the Project, including a determination by the
9		Construction Manager of a Guaranteed Maximum Price for the construction of the
10		Project; and
11	WHEREAS,	upon acceptance of the Guaranteed Maximum Price, the Construction Manager is
12		required to enter into a Contract and General Conditions (Maximum Guaranteed
13		Price) with the Nation (the "Construction Contract") for the construction of the
14		Project, a form of which is attached hereto as Exhibit "A" to the Construction
15		Management Contract; and
16	WHEREAS,	the Construction Management Contract and the Construction Contract provide
17		remedies for claims asserted by the Construction Manager and Construction
18		Contractor which are only enforceable upon approval by the Tohono O'odham
19		Legislative Council of a limited waiver of sovereign immunity in each Contract; and
20	WHEREAS,	the Health & Human Services Committee and the Budget & Finance Committee
21		recommend approval of this Resolution by the Legislative Council.
22	NOW, THER	EFORE, BE IT RESOLVED THAT:
23		1. The Tohono O'odham Legislative Council hereby grants a limited waiver of
24		sovereign immunity with respect to claims and remedies of the Construction
25		Manager on the conditions prescribed in Paragraph 15 of the Construction
26		Management Contract.

1	2. The Legislative Council hereby grants a limited waiver of sovereign immunity

3	conditions prescribed in Paragraph 19.5 of the Construction Contract.
4	3. The limited waiver of sovereign immunity in each Contract shall be effective on
5	the date the Contract is fully executed, the Nation issues a notice to proceed and
6	the Contract is in substantially the form attached hereto.

8	of <u>DECEMBER, 2004</u> at a meeting at which a quorum was present with a vote of <u>2,463.4</u> FOR; <u>-0-</u>

10	Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
11 12	O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
13	Stat. 984).
