5	WHEREAS, the Administration Budget (11-1628) has been reduced \$6,561.45 for final allocation					
6	adjustment; the Employment Cost Budget (11-1629) has been reduced \$225.28 for					
7	final allocation adjustment; the Training Assistance Budget (11-1630) has been					
8	reduced \$9,140.61 for final allocation adjustment; and the Other Program Services					
9	Budget has been decreased \$7,772.26 for final allocation adjustment.

11	approve the Department of Labor – Supplemental Youth Services PY 2003 annual					
12	budget modification #1 reducing Administration Budget (11-1628) \$6,561.45;

14	\$9,140.61 and decreasing Other Program Services Budget (11-1631) \$7,772.26 to the
