

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing FY 2005 Expenditures from the SAWRSA Trust Fund for Continuation of**  
**Efforts to Complete Tribal Responsibilities and Obligations Related to Utilization of**  
**Central Arizona Project Water and Irrigation Systems)**

**RESOLUTION NO. 04-698**

1 **WHEREAS, the Tohono O'odham Legislative Council, by means of Resolution No. 99-334,**  
2 **authorized and directed the completion of tribal responsibilities and obligations**  
3 **related to construction of facilities for utilization of Central Arizona Project water and**  
4 **irrigation systems in the eastern Schuk Toak District; and**

5 **WHEREAS, portions of work identified for FY 2004 were not completed and are being budgeted for**  
6 **into the FY 2005 as reflected in the attached budget and justification; and**

7 **WHEREAS, the Water Projects Office submitted the attached budget and justification for FY 2005**  
8 **to continue the scope of work authorized under Resolution No. 99-334 for an amount**  
9 **of \$116,387.53; and,**

10 **WHEREAS, the Water Projects Office requests from the Tohono O'odham Legislative Council,**  
11 **approval of funding from the SAWRSA Trust Fund to enable completion of tribal**  
12 **responsibilities and obligations related to utilization of Central Arizona Project water**  
13 **and irrigation systems in the eastern Schuk Toak District.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
15 **hereby approves the funding request and authorizes the expenditures in the amount**  
16 **of \$116,387.53 to complete tasks indicated in the attached budget for fiscal year 2005.**

17 **BE IT FINALLY RESOLVED that funds in the amount of \$116,387.53 are hereby appropriated**  
18 **from the SAWRSA Trust Fund to cover expenditures during the period from October**  
19 **1, 2004 through September 30, 2005.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>, Day**  
21 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; 166.3**  
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
