

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the FY05 Operating Budget of KOHN-FM Radio Station and
appropriating an additional \$381,028.16 for the remaining period of
January 1, 2005 through September 30, 2005)**

RESOLUTION NO. 04-702

1 **WHEREAS, pursuant to Legislative Council Resolution No. 2000-515, the Office of the**
2 **Chairwoman is presently operating KOHN-FM under a budget set aside from the**
3 **Nation's savings account; and**

4 **WHEREAS, by Resolution No. 04-615 the Tohono O'odham Legislative Council did authorize the**
5 **continued use of the estimated unexpended balance of \$52,771.77 remaining at fiscal**
6 **year 2004; and**

7 **WHEREAS, an additional \$47,061.07 has been approved within the Executive Branch overall**
8 **budget to supplement the operations of KOHN-FM until December 31, 2004; and**

9 **WHEREAS, the Executive Branch has prepared and presented an amendment, in the amount of**
10 **\$381,028.16, to the operating budget to fund the remaining period of January 1, 2005**
11 **through September 30, 2005.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**
13 **operating budget of KOHN-FM is hereby amended in the amount of \$381,028.16 for**
14 **the remaining period of January 1, 2005 through September 30, 2005 bringing the**
15 **total operating budget for KOHN-FM to \$484,610.99.**

16 **BE IT FURTHER RESOLVED that the additional funds of \$381,028.16 are allocated from the**
17 **unobligated general fund revenue base.**

18 **BE IT FINALLY RESOLVED that the Executive Office of the Chairwoman is hereby authorized to**
19 **expend these funds in accordance to the attached budget.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
21 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,802.4 FOR; 646.45**
22 **AGAINST; 180.85 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**




