

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Modifying Enrollment Resolution No. 17-88)**

**RESOLUTION NO. 05-005**

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and Ordinances for**  
2 **governing the enrollment and adoption of members and the relinquishment and loss**  
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1(b);**  
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 5-81 (As amended)**  
6 **provides that the Legislative Council shall determine Applicant’s eligibility for**  
7 **enrollment or adoption; and**

8 **WHEREAS, on February 1, 1988 the Legislative Council, pursuant to Resolution No. 17-88,**  
9 **approved Fredina D. Joaquin, 1517-SO-87 for membership in the Tohono O’odham**  
10 **Nation; and**

11 **WHEREAS, the Enrollment Committee has determined, based on the individual’s date of birth,**  
12 **and family tree, that Fredina D. Joaquin listed with Roll No. 1517-SO-87 was given the**  
13 **same number assigned to another member; and**

14 **WHEREAS, the Enrollment Manual at page 5, (Filing of applications) provides that once a number**  
15 **has been assigned to an application it shall not be changed; and**

16 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O’odham**  
17 **Legislative Council shall cause the membership roll to be kept current.**

18 **NOW, THEREFORE, BE IT RESOLVED THAT:**

19 **1. The Tohono O’odham Legislative Council approves a modification of Resolution**  
20 **No. 17-88 as follows:**

21 **The Roll No. listed for Fredina D. Joaquin is changed to 2420-SO-87 to reflect the**  
22 **number originally assigned to the application of Fredina D. Joaquin in 1987**  
23 **which was approved by the Council pursuant to Resolution No. 17-88.**

24 **2. The Enrollment Committee shall make the necessary changes in the records of**  
25 **the Enrollment office to incorporate the stated modification.**

26 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 03<sup>RD</sup>. Day**  
27 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 2,367.7 FOR; -0-**  
28 **AGAINST; 262.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (1) of Article VI of the Constitution of the Tohono O’Odham Nation, adopted by the Tohono**  
30 **O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
