

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 Attorney Contract for: Lawrence O. Boswell to Serve as a Conflict Attorney)

RESOLUTION NO. 05-024

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain Lawrence O. Boswell to be appointed to**
5 **represent clients with conflict of interest who can not be represented by the Nation's**
6 **Advocate program; and**

7 **WHEREAS, the Advocate Program had presented a contract for Lawrence O. Boswell which**
8 **confirms and ratifies the terms and conditions related to his services, a copy of which**
9 **is attached; and**

10 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
11 **an Attorney Contract with Lawrence O. Boswell on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**
14 **Attorney Contract for Lawrence O. Boswell in the forms attached hereto for the**
15 **period of October 1, 2004 through September 30, 2005 in the amount not to**
16 **exceed \$65,000.00 total.**
- 17 **2. Funding for the Conflict Attorney Contract for Lawrence O. Boswell shall be**
18 **provided under the operating budget of the Advocate Program for Fiscal Year**
19 **2005.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
21 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 1,803.0 FOR; 253.6**
22 **AGAINST; 381.7 NOT VOTING; and 191.4 [07] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
