

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Budget Modification No. 1 for the San Xavier District FY 2005 Budget)**

**RESOLUTION NO. 05-038**

1 **WHEREAS, the San Xavier District Chairman submitted a proposal at the Legislative Council**  
2 **session held on January 7, 2005 regarding a budget modification; and**

3 **WHEREAS, the budget modification in the amount of \$10,165.00 will be used to repair certain**  
4 **roads in the areas needed for mail deliveries or the United States Postal Service will**  
5 **discontinue their services to the affected San Xavier District residents; and**

6 **WHEREAS, a letter was received dated January 4, 2005 from the United States Postal Service on**  
7 **this matter and mentioned the following roads that need maintenance:**

8 **South Sudag Wog**

9 **West Community Lane**

10 **West Wa:k Lane**

11 **West Koli Ki Wog; and**

12 **WHEREAS, the Little White Dove Construction, L.L.C. has been recommended by the District to**  
13 **perform this project with no objections by the Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
15 **a budget modification in the amount of \$10,165.00 towards road maintenance on the**  
16 **above roads mentioned for mail deliveries to accommodate the San Xavier District**  
17 **Community.**

18 **BE IT FURTHER RESOLVED that the amount of \$10,165.00 will be taken out from the District's**  
19 **operating investments and transferred to the Maintenance department line item**  
20 **#7065.**

21 **BE IT FINALLY RESOLVED that the San Xavier District FY 05 budget is hereby increased for a new**  
22 **total of \$5,426,567.26.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
24 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 2,438.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and 191.4 [04] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**
