- 1 **WHEREAS, many birth defects are preventable; and**
- 2 **WHEREAS, the Tohono O'odham Nation wishes to provide preventive health services to its tribal**  
3 **members who reside in Sonora, Mexico, as resources allow; and**
- 4 **WHEREAS, Healthy Gente 2010 of the U.S. - Mexico Border Health Commission (USMBHC)**  
5 **encourages border communities to address the reduction of illness and death due to**  
6 **preventable birth defects; and**
- 7 **WHEREAS, the USMBHC has awarded funds to the Tohono O'odham Nation to conduct birth**  
8 **defects prevention reduction education with the Nation's tribal members who reside**  
9 **in Sonora, Mexico.**

10 **NOW, THEREFORE, BE IT RESOLVED:**

- 11           1. **The Tohono O'odham Legislative Council approves the FY 05 Healthy**  
12 **Gente/Healthy Border Mini Grant in the amount of \$9,949.00 from the Arizona**  
13 **Department of Health Services (ADHS) for this purpose, and authorizes to expend**  
14 **the allocated funds for the period August 05, 2004 to August 04, 2005.**
- 15           2. **The Tohono O'odham Nation Official, to wit: the Chairwoman and Vice Chairman**  
16 **or any designated Official is hereby authorized to negotiate and execute the**  
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
19 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 2,438.3 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 191.4 [04] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
