

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Title VI, Part A Program Grant Proposal)**

RESOLUTION NO. 05-045

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**
4 **part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, the Title VI Part A Program is requesting approval of a three year project grant**
6 **proposal which shall commence April 1, 2005 and end March 31, 2008; and**


7 **WHEREAS, the Title VI Part A Program is also requesting approval on the prepared budget of**
8 **\$179,810.00 that shall cover the first year (April 1, 2005 to March 31, 2006) of the three-**
9 **year project.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
11 **approves:**

- 12 1. **The Title VI, Part A Program three-year project grant proposal that shall**
13 **commence April 1, 2005 and end March 31, 2008; and**
- 14 2. **The Title VI, Part A Program first year budget of \$179,810.00 and the expending**
15 **of funds from April 01, 2005 through March 30, 2006.**
- 16 3. **The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
17 **authorized to negotiate and execute the grant, provided however, that any**
18 **amendments affecting the funding or funding levels of this contract shall be**
19 **submitted for further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
21 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 2,438.3 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 191.4 [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
