

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Title VI, Part C - Native American Family Caregiver Support
Program Grant Proposal)**

RESOLUTION NO. 05-046

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**
4 **part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, the Title VI Part C Native American Family Caregiver Support Program is requesting**
6 **approval of a three year project proposal that shall commence on April 1, 2005 and**
7 **end March 31, 2008; and**

8 **WHEREAS, the Title VI Part C Native American Family Caregiver Support Program is also**
9 **requesting approval on the prepared budget of \$67,990.00 that shall cover the first**
10 **year (April 1, 2005 to March 31, 2006) of the three-year project.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves:**

13 **1. The Title VI, Part C Native American Family Caregiver Support Program three-**
14 **year project proposal that shall commence April 1, 2005 and end March 31, 2008;**

15 **and**

16 **2. The Title VI, Part C Native American Family Caregiver Support Program first year**
17 **budget of \$67,990.00 and the expending of funds from April 01, 2005 through**
18 **March 30, 2006.**

19 **3. The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
20 **authorized to negotiate and execute the grant, provided however, that any**
21 **amendments affecting the funding or funding levels of this contract shall be**
22 **submitted for further prior approval by this Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
25 **of JANUARY, 2005 at a meeting at which a quorum was present with a vote of 2,438.3 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 191.4 [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
