

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Consolidated Healthy O'odham Promotion Program FY 2005 Budget
(October 1, 2004 – September 30, 2005))

RESOLUTION NO. 05-058

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2009 with a base budget of \$1,929,827.00 with additional carryover**
3 **funding of \$2,406,068.77; and**

4 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
5 **establishment of the Community Based Diabetes Prevention Program, funded by the**
6 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**
7 **1997; and**

8 **WHEREAS, by Resolution No. 98-150, the Tohono O'odham Legislative Council approved the**
9 **establishment of the Data Improvement Program under the Special Diabetes**
10 **Programs for Indians, authorized by the Balanced Budget Act of 1997; and**

11 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the**
12 **name change of the Community Based Diabetes Prevention Program to the Healthy**
13 **O'odham Promotion Program; and**

14 **WHEREAS, the Tohono O'odham Department of Human Services is requesting the Fiscal Year**
15 **2005 base budget of \$1,929,827.00 and carryover funding of \$2,406,068.77, for a total**
16 **budget of \$4,335,895.77.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 18 **1. Approves the Division of Health Promotion Program Fiscal Year 2005 budget for**
19 **\$4,335,895.77; and**
- 20 **2. Approves the addition of the Renovations line item to the budget in the amount**
21 **of \$300,000; and**
- 22 **3. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice**
23 **Chairman and any designated Official are hereby authorized to negotiate and**
24 **execute the grant and expend funds associated with this budget.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH, Day**
26 **of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**




