1 **WHEREAS, the Tohono O'odham Nation Explorer Post #99 is requesting funds to attend the 2005**
2 **National Fire/Emergency Exploring Conference at Texas A&M University System**
3 **College Station in Texas during the dates of June 20th through the 24th 2005; and**

4 **WHEREAS, the Explorer Post #99 has requested to receive funds through the approval of**
5 **Legislative Council; and**

6 **WHEREAS, the Tohono O'odham Nation has requested for assistance, with the intent of**
7 **representing the Nation at the 2005 National Fire/Emergency Exploring Conference;**
8 **and**

9 **WHEREAS, the Tohono O'odham Nation Explorer Post #99 has asked to be granted funds to**
10 **attend the 2005 National Fire/Emergency Exploring Conference to represent the**
11 **Nation at a National level and to further their learning experience gained through**
12 **participating in competitions and seminars scheduled such as Career Track for**
13 **exploring careers options in the fire service, Terrorism and Weapons of Mass**
14 **Destruction, Fire Prevention and Investigations, and team drill competitions; and**

15 **WHEREAS, the Tohono O'odham Nation Explorer Post #99 requests the acceptance of the funds**
16 **to attend.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **above-mentioned 2005 National Fire/Emergency Services Exploring Conference as it**
19 **pertains to the attached Tohono O'odham Nation's Explorer Post #99.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Explorer Post #99 is authorized to**
21 **expend funds from the FY05 Surplus in the amount of \$2,200.00 from this award**
22 **beginning June 20, 2005 through June 24, 2005.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
24 **of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
25 **AGAINST; 166.3 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
