

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Legislative Branch FY 2005 Budget Amendment No. 1)

RESOLUTION NO. 05-082

1 **WHEREAS, the Legislative Branch FY 2005 Budget was approved by Resolution No. 04-650; and**
2 **WHEREAS, the Legislative Branch is requesting approval of its Proposal of Agreement for**
3 **Information & Technology Support Services as Budget Amendment No. 1 for the**
4 **Tohono O'odham Legislative Branch; and**
5 **WHEREAS, the Proposal of Agreement includes the transfer of one position salary including**
6 **fringe benefits, and training registration and tuition; and**
7 **WHEREAS, the total amount of funds to be transferred Budget Amendment No. 1 is \$29,171.52;**
8 **and**
9 **WHEREAS, the transfer of funds from Account No. 01-1002 (Tohono O'odham Legislative Branch)**
10 **to Account No. 01-1021 (Department of Information & Technology under the Executive**
11 **Branch); and**
12 **WHEREAS, the transfer of these funds from Account No. 01-1002 will reduce the Tohono O'odham**
13 **Legislative Branch Budget to \$2,364,775.48; and**
14 **WHEREAS, the Budget and Finance Committee on February 04, 2005 did review the FY 2005**
15 **Legislative Branch Budget Amendment No. 1.**
16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves the attached FY 2005 Legislative Branch Budget Amendment No. 1.**
18 **BE IT FINALLY RESOLVED that the transfer of funds between Tohono O'odham Legislative Branch**
19 **and Department of Information & Technology under the Executive Branch will**
20 **decrease the base budget of the Tohono O'odham Legislative Branch in the amount**
21 **of \$29,171.52.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
23 **of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 1,384.1 FOR; 1,061.6**
24 **AGAINST; 184.0 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
