6		from the Institute of Museum and Library Services (IMLS) Native American Library
7		Services (NALS) by Resolution No. 03-515 to create a basic library federation of the
8		existing Tohono O'odham tribal libraries (Pisinemo, San Lucy Library and Archives,
9		San Xavier Learning Center Library, Sells [Venito Garcia Library and Archives] and
10		additional tribal libraries that may come into being, with a common online catalog,
11		systemic inter-library loan, and mutual borrowing conventions to create an inter-
12		library loan; and
13	WHEREAS,	the Enhancement Grant had a carry over of FY-2004 funds in the amount of \$438.38;

15	WHEREAS,	the Tohono O'odham Legislative Council authorized \$71,625.00 for FY 2004 and
16		required reauthorization of the grant funds for FY 2005 for \$71,625.00 by Resolution
17		No. 03-515.
