

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Authorizing Expenditure of Arizona State Grant-in-Aid No. 241-4-1-(04)
for the Venito Garcia Library and Archives from the Arizona State Library, Archives
and Public Records)

RESOLUTION NO. 05-086


1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**
4 **Tohono O'odham Nation, and has received this grant award since 2000 to help with**
5 **the Library's archives and special collections.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
7 **grant to the Venito Garcia Library and Archives from the Arizona State Library,**
8 **Archives and Public Records for a grant to support the archives and special**
9 **collections efforts of the Library, for the amount of \$6,000.00 with an in-kind**
10 **contribution of \$14,500.00, and authorizes the use of the funds provided by the Venito**
11 **Garcia Library and Archives, and waives indirect costs which is a requirement of this**
12 **particular grant.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
14 **of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
19 **Stat. 984).**
