

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending the final cost in Resolution No. 04-678, "Approving a \$500.00 Christmas  
Bonus for Employees, Appointed Directors, Elected Officials, and Judges of the  
Tohono O'odham Nation")**

**RESOLUTION NO. 05-097**

1 **WHEREAS, the Tohono O'odham Legislative Council through Resolution No. 04-678 approved a**  
2 **\$500.00 Christmas Bonus for the Employees, Appointed Directors, Elected Officials,**  
3 **and Judges; and**

4 **WHEREAS, the amount approved, \$798,493.70, was appropriated from the General Fund and**  
5 **authorized to be expended in accordance with the budget; and**

6 **WHEREAS, the total amount expended for the Christmas Bonus was \$638,928.89.**

7 **NOW, THEREFORE, BE IT RESOLVED that the final cost including associated taxes for the Christmas**  
8 **Bonus is \$638,928.89 and that the Legislative Council approves that the difference of**  
9 **\$159,564.81 be returned to the General Fund.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
11 **of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**
