

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorization for the District Water Advisory Committee to Expend a Budget of**  
**Accrued SAWRSA Trust Fund Interest for FY 2005)**

RESOLUTION NO. 05-107

1 WHEREAS, section 303 (b)(1) of the Southern Arizona Water Rights Settlement Act (SAWRSA) of  
2 1982 authorized a study to determine the availability and suitability of water  
3 resources within the Sells Tohono O'odham Reservation; and

4 WHEREAS, pursuant to Resolution 19-85 the Papago Tribal Council, now known as the Tohono  
5 O'odham Legislative Council (the "Legislative Council"), established a water  
6 management committee; and

7 WHEREAS, in FY 2002 the Water Management Committee evolved into the District Water Advisory  
8 Committee a recognized committee of the Tohono O'odham Nation; and

9 WHEREAS, SAWRSA had historically provided an operational budget for the Water Management  
10 Committee, that annual operational budget of \$121,250.00 should be reallocated to  
11 the District Water Advisory Committee; and

12 WHEREAS, this budget has been reviewed by the Water Resources Committee and the Budget and  
13 Finance Committee and is recommended for approval by the Legislative Council.

14 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council acknowledges that the Water  
15 Management Committee has evolved into and become the District Water Advisory  
16 Committee and that the associated Water Management Committee budget should be  
17 allocated to the District Water Advisory Committee.

18 BE IT FINALLY RESOLVED that the total budget funding for fiscal year 2005 of  
19 \$121,250.00 from the SAWRSA interest dollars for the District Water Advisory  
20 Committee is approved in accordance with the budget attached hereto retroactive  
21 to October 01, 2004.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> Day  
23 of FEBRUARY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-  
24 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
25 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
26 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
27 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
28 18, 1934 (48 Stat. 984).
