10	WHEREAS,	the Human Resources Officer recommends an Attorney Contract with the Attorney in						
11		the amount of \$4,000 for the period from October 1, 2004 through September 30, 2005;

13	WHEREAS,	the fiscal year 2005 budget for the Human Resources Office (01-1005-810) has						
14		sufficient funds for the Contract amount; and						
15	WHEREAS,	the Human Resources Development Committee, Domestic Affairs Committee and the						
16		Budget & Finance Committee recommend approval of the Attorney Contract by the						
17		Legislative Council.
