

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Shelley, Bethea, Gillette & Clark PLC)

RESOLUTION NO. 05-121

1 **WHEREAS, it is advisable that the Human Resources Office has available independent legal**
2 **representation for employment issues in which the Office of Attorney General is**
3 **unable to provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Human Resources Office recommends an Attorney Contract with the law firm of**
5 **Shelley, Bethea, Gillette & Clark (the "Attorneys") to provide legal representation to**
6 **the Human Resources Office for the foregoing purposes; and**

7 **WHEREAS, the proposed Attorney Contract is in the amount of \$21,000 for the period from**
8 **October 1, 2004 through September 30, 2005; and**

9 **WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for**
10 **fiscal year 2005 includes sufficient funds for the Attorney Contract; and**

11 **WHEREAS, the Budget & Finance Committee, Domestic Affairs Committee and the Human**
12 **Resources Development Committee recommend approval by the Legislative Council**
13 **of an Attorney Contract.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
16 **with the law firm of Shelley, Bethea, Gillette & Clark in the amount of \$21,000 for**
17 **the fiscal year beginning October 01, 2004 ending September 30, 2005 and in the**
18 **form attached hereto.**
- 19 **2. Funding for the Attorney Contract in fiscal year 2005 shall be provided under the**
20 **operating budget of the Human Resources Office (Account No. 01-1005-810).**
- 21 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
22 **contract.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
24 **of MARCH, 2005 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 465.6 [05] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
