

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Approve the Use of Gaming Savings to fund the Enrollment Program a FY05
(Four Month) Budget in the amount of \$84,851.08)**

RESOLUTION NO. 05-124

1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative cost**
2 **of implementing the provisions of the initiative; and**

3 **WHEREAS, a reserve was established to fund the necessary administrative requirements; and**

4 **WHEREAS, the Nation will establish for all eligible Minors an interest bearing account at a**
5 **reputable financial institution; and**

6 **WHEREAS, the Enrollment Program will conduct a major outreach for the Nation to assure that**
7 **all minors eligible for the 1997 and 1999 per capita payment complete the Eligibility**
8 **Verification form required by the financial institute selected by the Nation; and**

9 **WHEREAS, the Enrollment Program will need additional funding to conduct a major outreach**
10 **to process the minor eligibility forms throughout the Nation, surrounding**
11 **communities, cities, Mexico and the State of California; and**

12 **WHEREAS, the Enrollment Program will utilize these additional funds of \$84,851.08 to hire**
13 **temporary support workers and operational costs expenses to complete the Eligibility**
14 **Verification processing of all minors.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **recognize the need to establish a Minor Account with a financial institute for all**
17 **minors eligible for per capita payment.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves gaming savings**
19 **funds in the amount of \$84,851.08 to the Enrollment Program to conduct a major**
20 **outreach to process the Minor Eligibility Verification forms of all minors in the**
21 **Nation.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
23 **of MARCH, 2005 at a meeting at which a quorum was present with a vote of 2,454.3 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 175.4 [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
