

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the P.L. 93-638 Allocation Amount for Judicial Services reduced
from \$342,790.11 to \$340,947.87)

RESOLUTION NO. 05-128

1 **WHEREAS, on December 07, 2004 the Tohono O'odham Legislative Council Resolution No. 04-612**
2 **approved the P.L. 93-638 Master Contract in the amount of \$11,695.621.35, which**
3 **allocated \$342,790.11 for Judicial Services; and**


4 **WHEREAS, according to the United States Department of the Interior Office of Self-**
5 **Determination a modification to the Nation's Master Contract reduces the original**
6 **allocation for Judicial Services; and**

7 **WHEREAS, this reduction does decrease the amount authorized by the Tohono O'odham**
8 **Legislative Council by \$1,842.24 resulting in a reduction from \$342.790.11 to**
9 **\$340,947.87 (Attachment) for Judicial Services.**

10 **NOW, THEREFORE, BE IT RESOLVED that due to a modification by the United States Department**
11 **of the Interior the original allocation for Judicial Services be reduced from**
12 **\$342,790.11 to \$340,947.87**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
14 **of MARCH, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
19 **Stat. 984).**




