4	Title VI of the Older American's Act of 1978 as amended; and
5	WHEREAS, the Division of Senior Services requests approval of the Title VI, Part A Program budget
6	modification #1 that reflects the Indirect Cost percentage rate increase from 16.69%
7	to 17.10%; and
8	WHEREAS, the budget modification also reflects the 2.5% salary adjustment for employees under
9	the Title VI, Part A Program; and
10	WHEREAS, funds from other line items within the budget will be used to cover the Indirect Cost
11	percentage rate increase and the 2.5% salary adjustment.
12	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
13	approves:
14	1. The Title VI, Part A Program budget modification #1 that reflects the Indirect Cost
15	percentage rate increase from 16.69% to 17.10% and the 2.5% salary adjustment
16	for employees under the program.
17	2. The transfer of funds from other line items within the budget to cover the Indirect
18	Cost percentage rate increase and the 2.5% salary adjustment.
19	3. The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby
20	authorized to negotiate and execute the grant, provided however, that any
21	amendments affecting the funding or funding levels of this contract shall be
22	submitted for further prior approval by this Council.
