

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Department of Human Services, Division of Family Assistance - FY05**  
**Low Income Home Energy Assistance Program Budget Modification No. 1,**  
**Account No. 12-1310)**

**RESOLUTION NO. 05-135**

1 **WHEREAS, Low income Home Energy Assistance Program (LIHEAP) has been beneficial in**  
2 **providing financial assistance to eligible low-income households in meeting utility**  
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, funds have been made available to the Tohono O'odham Nation for FY2005 through**  
5 **the State of Arizona, Department of Economic Security, Community Services**  
6 **Administration; and**

7 **WHEREAS, the Tohono O'odham Nation does meet the eligibility requirements to operate a Low**  
8 **Income Home Energy Assistance Program; and**

9 **WHEREAS, the Tohono O'odham Nation's application for FY2005 funding was approved through**  
10 **the State of Arizona, Department of Economic Security, Community Services**  
11 **Administration in the amount of \$53,980.00 for contract period July 01, 2004 through**  
12 **June 30, 2005; and**

13 **WHEREAS, any amendments affecting the funding or funding levels of the contract shall be**  
14 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

15 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division,**  
16 **Low Income Home Energy Assistance Program has submitted the attached budget**  
17 **modification No. 1 for review and approval. Budget modification No. 1 decreases**  
18 **the Office Supply line item to cover the increase in the Indirect Cost from 16.69% to**  
19 **17.10%. The total budget amount remains at \$53,980.00.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

21 **1. It hereby approves and authorizes the budget modification No. 1 for the FY2005**  
22 **Low Income Home Energy Assistance Program (LIHEAP) and authorizes**  
23 **expenditures in accordance with the attached budget.**

24 **2. That the Tohono O'odham Nation's official to wit: The Chairwoman is hereby**  
25 **authorized to negotiate and execute the contract.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
27 **of MARCH, 2005 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and 465.6 [05] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
