

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorization for a No Cost Extension for the Department of Justice – Tribal Resources Grant Program, Grant #2003HEWX114 for the Tohono O'odham Nation Police Department – Ending Date of August 31, 2005)

RESOLUTION NO. 05-138

1 WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has successfully received
2 an award with the Community Oriented Policing Services (COPS) – Tribal Resources
3 Grant Program (TRGP) Equipment Award, funded through the U.S. Department of
4 Justice (USDOJ) for the project amount of \$537,300 under Grant Award Number
5 2003HEWX0114; and

6 WHEREAS, the TONPD used these funds specifically for equipment needed; and

7 WHEREAS, a remaining balance of \$18,517.62 remains under this grant; and

8 WHEREAS, the TONPD has requested a no-cost extension with the USDOJ-COPS for the use of
9 these remaining funds; and

10 WHEREAS, the USDOJ has approved the TONPD request and extended the Grant period to August
11 31, 2005; and


12 WHEREAS, the TONPD requests the Tohono O'odham Nation Legislative Council to approve the
13 acceptance of this grant extension and budget in the amount of \$18,517.62.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it
15 hereby accepts and authorized the implementation and expenditures of this no-cost
16 grant extension and budget of \$18,517.62 for the TRGP Grant #2003HEWX0114.

17 BE IT FINALLY RESOLVED, by the Tohono O'odham Nation Legislative Council that it hereby
18 accepts the extension date of August 31, 2005.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day
20 of MARCH, 2005 at a meeting at which a quorum was present with a vote of 2,437.1 FOR; -0-
21 AGAINST; -0- NOT VOTING; and 192.6 [06] ABSENT, pursuant to the powers vested in the Council by
22 Section I (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).
