

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Utility Authority North Santa Rosa Wastewater System
Improvements Right-of-Way, Gu Achi District, Tohono O'odham Nation)

RESOLUTION NO. 05-140

- 1 **WHEREAS, by Resolution No. 08-70 the Nation established the Papago Tribal Utility Authority,**
2 **now known as Tohono O'odham Utility Authority (TOUA) for purposes of constructing,**
3 **maintaining and operating various utility systems within the Nation to be owned**
4 **wholly by the Nation; and**
- 5 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 91-175 (Adopting**
6 **Second Restated Plan of Operation for the Tohono O'odham Utility Authority) which**
7 **requires the Authority to submit for prior review and approval of the Legislative**
8 **Council and each affected District any proposed utility easement; and**
- 9 **WHEREAS, TOUA requests permission for a Right-of-Way to construct the Wastewater System**
10 **Improvements and related facilities to serve the community of North Santa Rosa, Gu**
11 **Achi District, Tohono O'odham Nation; and**
- 12 **WHEREAS, the requested Right-of-Way consists of a parcel of land 600' x 550' encompasses 7.576**
13 **acres more or less; and**
- 14 **WHEREAS, TOUA has respectfully submitted all documents and pertinent information**
15 **(incorporated herein by reference) for uses consistent with the authorized purposes**
16 **of TOUA; and**
- 17 **WHEREAS, the North Santa Rosa Wastewater System Improvements and related facilities will be**
18 **of substantial benefit to the North Santa Rosa Community, Gu Achi District, the**
19 **Tohono O'odham Nation and their respective members; and**
- 20 **WHEREAS, the North Santa Rosa Community by consensus approved the Wastewater System**
21 **Improvements Right-of-Way at a meeting on 22 February 2005; and**
- 22 **WHEREAS, the Gu Achi District Council approved the requested Right-of-Way by enacting**
23 **Resolution No. 0205-496 on February 25, 2005; and**
- 24 **WHEREAS, the Natural Resources Committee reviewed the Right-of-Way on February 28, 2005 and**
25 **by consensus recommends approval thereof by the Tohono O'odham Legislative**
26 **Council.**
- 27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
28 **approve the Right-of-Way as requested by TOUA for the North Santa Rosa Wastewater**
29 **System Improvements and related facilities in the location (as more fully described**
