11		budget in the amount of \$1,939.00 for review and approval.

13		1. It hereby approves and authorizes the FY2005 Food Distribution Nutrition
14		Education budget in the amount of \$1,939.00 and authorizes expenditures in
15		accordance with the attached budget.

17		authorized to negotiate and execute the grant.
