

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 Well Maintenance Program Budget (01-1045) Amendment No. 1)**

RESOLUTION NO. 05-164

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Well Maintenance Program**
2 **FY 2005 budget with Council Resolution No. 04-609; and**

3 **WHEREAS, any amendments affecting the funding or funding levels of the budget shall be**
4 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

5 **WHEREAS, the Tohono O'odham Legislative Council has authorized a percentage of the FY 2005**
6 **General Revenue Surplus to the Executive Branch by Council Resolution No. 05-080;**
7 **and**

8 **WHEREAS, \$150,000.00 of the Executive Surplus will be allocated to the FY 2005 Well Maintenance**
9 **Program budget - line items 630-INSURANCE, 712-GAS, OIL & COOLANTS, 725-WELL**
10 **SUPPLIES, and 750-MAJOR CAPITAL; and**

11 **WHEREAS, this budget has been reviewed by the Tohono O'odham Water Resources Committee**
12 **and the Budget and Finance Committee and has been recommended for approval by**
13 **the Tohono O'odham Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that it hereby**
15 **approves and authorizes expenditure of the Executive Surplus of \$150,000.00 for the**
16 **Well Maintenance Program FY 2005 Budget Amendment No. 1.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that this is a one-time**
18 **funding allocation and adjusted budget will revert to the Base Budget in FY 2006.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
20 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
