

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY-2005 Natural Resources Administration Budget (01-5015) Amendment No. 1)**

RESOLUTION NO. 05-165

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY 2005 Natural Resources  
2 Administration Budget with Council Resolution No. 04-609; and

3 WHEREAS, any amendments affecting the funding or funding levels of the budget shall be  
4 submitted for review and approval by the Tohono O'odham Legislative Council; and

5 WHEREAS, the Tohono O'odham Legislative Council has designated a percentage of the FY- 2005  
6 General Revenue Surplus to the Executive Branch by Council Resolution No. 05-080;  
7 and

8 WHEREAS, line item 778 ALTERATION and RENOVATIONS will be added to the Natural Resources  
9 Administration budget; and

10 WHEREAS, \$263,000.00 of the Executive Surplus will be allocated to the FY-2005 Natural  
11 Resources Administration budget line items 772 PROGRAM SUPPLIES, 751  
12 LEASE/RENTALS, and 778 ALTERATION and RENOVATIONS; and

13 WHEREAS, this budget has been reviewed by the Tohono O'odham Natural Resources Committee  
14 and the Budget and Finance Committee and has been recommended for approval by  
15 the Tohono O'odham Legislative Council.

16 NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that it hereby  
17 approves and authorizes expenditure of the Executive Surplus of \$263,000.00 for the  
18 Natural Resources Administration FY 2005 Budget Amendment No. 1.

19 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that this is a one-time  
20 funding allocation and adjusted budget will revert to the Base Budget in FY 2006.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>. Day  
22 of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;  
23 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
24 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
25 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
