


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Tribal Facilities Management FY - 2005 Budget
Modification/Amendment No. 1)**

RESOLUTION NO. 05-171

1 **WHEREAS, the Tohono O'odham Nation operates the Tribal Facilities Management Program and**
2 **has successfully met the needs of the Tohono O'odham Programs; and**
3 **WHEREAS, the continued operation of the Tribal Facilities Management is essential to provide**
4 **custodial and maintenance services; and**
5 **WHEREAS, surplus dollars for Fiscal Year 2005 have been identified as accessible from the**
6 **Executive Surplus FY 05 General Revenue; and**
7 **WHEREAS, \$123,000.00 non-recurring funding will be allocated to the Tohono O'odham Tribal**
8 **Facilities Management budget for Fiscal Year 2005 to provide for Capital Equipment**
9 **and Repairs and Maintenance; and**
10 **WHEREAS, the Tohono O'odham Facilities Management Fiscal Year 2005 Budget Amendment No.**
11 **1 has been approved by the Office of the Chairwoman.**
12 **NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that it hereby**
13 **approves the Tohono O'odham Facilities Management Fiscal Year 2005 Budget**
14 **Amendment No. 1 in the amount of \$123,000.00.**
15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that this one time**
16 **funding allocation and adjusted budget will revert to the Base Budget in FY 06.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
18 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
20 **& (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**


