

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Tribal Motor Pool FY - 2005 Budget Modification/  
Amendment No. 1)**

**RESOLUTION NO. 05-172**

1 **WHEREAS, the Tohono O'odham Nation operates the Tribal Motor Pool and has successfully met**  
2 **the needs of the Tohono O'odham; and**

3 **WHEREAS, the continued operation of the Tribal Motor Pool is essential to provide service,**  
4 **maintenance and a secured parking area for all the Nation owned vehicles; and**

5 **WHEREAS, surplus dollars for Fiscal Year 2005 have been identified as accessible from the**  
6 **Executive Surplus FY05 General Revenue; and**

7 **WHEREAS, \$130,000, non-recurring funding, will be allocated to the Tohono O'odham Tribal**  
8 **Motor Pool budget for Fiscal Year 2005 to acquire a tow truck and establish a secured**  
9 **fenced parking area; and**


10 **WHEREAS, the Tohono O'odham Tribal Motor Pool Fiscal Year 2005 Budget Amendment No. 1 has**  
11 **been approved by the Office of the Chairwoman.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**  
13 **hereby approves the attached budget for the Tohono O'odham Tribal Motor Pool**  
14 **Fiscal Year 2005 Budget Modification/Amendment No. 1 in the amount of \$130,000.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that this one time**  
16 **funding allocation and adjusted budget will revert to the Base Budget in FY06.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
18 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
20 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
23 **Stat. 984).**
