RESOLUTION NO. 05-177

1 WHEREAS, pursuant to Legislative Council Resolutions 01-128, 03-085, 04-249 concerning the use
2 of Asset Forfeiture Funds; and
3 WHEREAS, the Tohono O'odham Nation Police Department submits its request for the
4 authorization and expenditure of funds to purchase seized property: two (2) pick-up
5 trucks, 1 hauling trailer and a quad off road cycle for a total of \$10,458.60; and
6 WHEREAS, the Tohono O'odham Nation Police Department is requesting to expend \$10,458.60
7 from the Asset Forfeiture Fund Account - Department of Justice.
8 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby accepts and approves the
9 authorization and expenditure for the acquisition of seized property: (2) pick-up
10 trucks, 1 hauling trailer and a quad off road cycle for a total budgeted amount of
11 \$10,458.60 to be funded from the Asset Forfeiture Fund Account - Department of
12 Justice, Account No. 0046-7808-3507.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
14 of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0- AGAINST;
15 465.6 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)
16 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
17 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
