

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2005 Tohono O'odham Nation Scholarship Fund Amendment No. 1)**

**RESOLUTION NO. 05-182**

1 **WHEREAS, the Tohono O'odham Nation Scholarship Fund has brought forth Amendment No. 1**  
2 **to its FY 2005 budget; and**

3 **WHEREAS, in Resolution No. 04-609, the Tohono O'odham Legislative Council approved the FY**  
4 **2005 Tohono O'odham Nation Scholarship Fund in the amount of \$5,537,953.95; and**

5 **WHEREAS, in Resolution No. 05-080, the Tohono O'odham Legislative Council approved**  
6 **Executive Surplus Funding from General Revenue; and**

7 **WHEREAS, the Tohono O'odham Nation Scholarship Fund has submitted for review and approval**  
8 **the proposed FY 2005 Budget Amendment No. 1, which increases line item number**  
9 **630 for Insurance and adds line item number 750 for Major Capital Equipment.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
11 **approve and authorize the expenditure of the attached budget for the Tohono**  
12 **O'odham Nation Scholarship Fund FY 2005 Budget Amendment No. 1 to the base**  
13 **budget of \$5,537,953.95 and add a one-time supplement from the Executive Surplus**  
14 **Funding of \$25,000.00.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that this one-time funding**  
16 **allocation and adjusted budget will revert to the Base Budget in FY 06.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairwoman is hereby authorized to**  
18 **negotiate and execute the budget provided that any amendments affecting the**  
19 **funding or funding levels of this budget shall be submitted for approval by this**  
20 **Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
22 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,414.3 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and 215.4 [03] ABSENT, pursuant to the powers vested in the Council by Section**  
24 **1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
