

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of Brauchli & Brauchli, P.C.)**

RESOLUTION NO. 05-190

1 **WHEREAS, the Cultural Affairs Program requires legal representation related to an assessment**
2 **of governance structures for the Tohono O'odham Cultural Center/Museum; and**
3 **WHEREAS, the Cultural Affairs Program recommends an Attorney Contract with the law firm of**
4 **Brauchli & Brauchli, P.C. (the "Attorneys") to provide the foregoing assessment; and**
5 **WHEREAS, attached hereto is an Attorney Contract with the Attorneys in the amount of \$24,500**
6 **for the period ending September 30, 2005; and**
7 **WHEREAS, the Cultural Preservation, Domestic Affairs and Budget & Finance Committees**
8 **recommend approval of the Attorney Contract.**

9 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 10 **1. The Legislative Council approves an Attorney Contract with the law firm of**
11 **Brauchli & Brauchli, P.C. in the amount of \$24,500 for period ending September**
12 **30, 2005.**
- 13 **2. Funding of the Attorney Contract shall be provided from the Cultural**
14 **Affairs/Museum Budget (Account No. 50-1516-810).**
- 15 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
16 **Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
18 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 1,636.1 FOR; 812.75**
19 **AGAINST; 180.85 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
