

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2005 Amendment #1 & Budget Modification #1 Request for the  
Tohono O'odham Nation Fire Department)**

**RESOLUTION NO. 05-191**

1 **WHEREAS, the Tohono O'odham Nation ("Nation"), established the Tohono O'odham Nation Fire**  
2 **Department in 1995 to provide fire protection and fire safety to all members of the**  
3 **Nation; and**

4 **WHEREAS, the Tohono O'odham Nation Fire Department has come before the Tohono O'odham**  
5 **Legislative Council and requested approval of amendment #1 & budget modification**  
6 **#1 to (1) add the amount of \$5000.00, as dictated by the Tohono O'odham Nation**  
7 **Executive Office to line item 750 Capital Equipment, (amendment #1) for the purchase**  
8 **of a washer-extractor which will be decreased from the FY '05 Executive Surplus as a**  
9 **one time amendment that it will revert back to the base budget approved by**  
10 **Legislative Council, (2) decrease by \$200.00, the line item 730 Dues & Subscriptions**  
11 **(modification #1) to be added into line item 750 Capital Equipment for shipping &**  
12 **handling charges for the purchase of a washer-extractor, (3) decrease by \$1000.00, the**  
13 **line item 650 Tuition & Registration (modification #1) to be added into line item 721**  
14 **Supplies - Other in the amount of \$1,000.00, for the modification for providing**  
15 **electricity and water service for the washer-extractor, and (4) decrease by \$2093.73,**  
16 **the line item 610.5 Other Compensation (modification #1) to be added into line item**  
17 **610 Salaries for the difference of the re-classifying salary and subsequent title change**  
18 **from Secretary to Administrative Secretary, of the Tohono O'odham Nation Fire**  
19 **Department FY 2005 Budget.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
21 **amendment #1 and authorizes to expend funds allocated from FY '05 Executive**  
22 **Surplus in the amount of \$5,000.00.**

23 **BE IT FINALLY RESOLVED, that this is a one time allocation and adjusted budget and will revert to**  
24 **the original base budget for FY '06, this clause referring to Amendment #1.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
26 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**  
28 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
