

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 Range Conservation and Management Program (10-1513)
Amendment No. 1)**

RESOLUTION NO. 05-197

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Range Conservation and**
2 **Management Program FY 2005 budget with Council Resolution No. 04-612; and**
3 **WHEREAS, any amendments affecting the funding or funding levels of the budget shall be**
4 **submitted for review and approval by the Tohono O'odham Legislative Council; and**
5 **WHEREAS, \$440,784.56 of FY 2004 Carry Forward funds will be allocated to the FY 2005 Range**
6 **Conservation and Management Program line items 630 INSURANCE, 712 GAS, OIL &**
7 **COOLANTS, 720 SUPPLIES-OFFICE, 721 SUPPLIES-OTHER, 722 PROGRAM SUPPLIES,**
8 **723 UNIFORMS, 730 DUES AND SUBSCRIPTIONS, 770 RM EQUIPMENT, 771 RM**
9 **VEHICLES, and 750 MAJOR CAPITAL; and**
10 **WHEREAS, this budget has been reviewed by the Tohono O'odham Agricultural Committee and**
11 **the Budget and Finance Committee and has been recommended for approval by the**
12 **Tohono O'odham Legislative Council.**
13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **approves and authorizes expenditure of \$440,784.56 of the Range Conservation and**
15 **Management Program budget Amendment No. 1, which will be added to the FY 2005**
16 **total budget of \$747,472.68 for a grand total amount of \$1,188,257.24.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
18 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
