(Approving the FY 2005 Tohono O'odham Nation Department of Information and
Technology Budget Modification/Amendment to 01-1021)**

RESOLUTION NO. 05-198

1 **WHEREAS, the Department of Information and Technology in meeting the needs and objectives**
2 **of FY 2005, is transferring funds from 778 Alterations and Renovations; and**

3 **WHEREAS, one new line item will be added to budget modification which is: 1) 750 Major Capital**
4 **Equipment; and**

5 **WHEREAS, the addition of the new line items will provide two new vehicles to meet the needs of**
6 **the staff so that services can be provided to the Executive Branch programs,**
7 **departments and districts to support overall mission and objectives.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
9 **FY 2005 Tohono O'odham Nation's Department of Information and Technology**
10 **request for budget modification/amendment reflecting the new line item: 1) 750**
11 **Major Capital Equipment.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
13 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
14 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
15 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
16 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
18 **Stat. 984).**


