

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Tribal Employment Rights Office FY 2005 Budget
Modification/Amendment No. 1)

RESOLUTION NO. 05-199

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**
2 **1978 and has successfully met the needs of the Tohono O'odham; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to**
4 **increase employment of Indians and eradicate employment discrimination within**
5 **the exterior boundaries of the Tohono O'odham Nation; and**

6 **WHEREAS, the Tohono O'odham Tribal Employment Rights Ordinance 01-85 is outdated; and**

7 **WHEREAS, surplus funding for Fiscal Year 2004 have been identified as accessible; and**

8 **WHEREAS, \$12,000, non-recurring funding, will be allocated to the Tohono O'odham Tribal**
9 **Employment Rights budget for Fiscal Year 2005 to acquire professional services to**
10 **revise Ordinance 01-85; and**

11 **WHEREAS, the Tohono O'odham Tribal Employment Rights Office Fiscal Year 2005 Budget**
12 **Modification/Amendment No. 1 has been approved by the Office of the Chairwoman.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **approves the Tohono O'odham Tribal Employment Rights Office's Fiscal Year 2005**
15 **Budget Modification/Amendment No. 1 increase of \$12,000.00 (non-recurring**
16 **funding); total funding amount of \$245,366.86.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH, Day**
18 **of APRIL, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
20 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**




