4 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does hereby**  
5 **recognize that the above-named person(s) have relinquished their membership in**  
6 **this Nation, and does hereby order that their name(s) be deleted from the**  
7 **membership roll.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02nd . Day**  
9 **of MAY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
10 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article II,**  
11 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**  
12 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
14 **18, 1934 (48 Stat. 984).**
