

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with the Law Firm of Quigley & Whitehill, P. L. C.)

RESOLUTION NO. 05-210

1 **WHEREAS, pursuant to Legislative Council Resolution No. 04-552, the Tohono O'odham Nation**
2 **(the "Nation") entered into an Attorney Contract with the law firm of Quigley &**
3 **Whitehill, P.L.C. (the "Attorneys") for Fiscal Year 2005 in the amount of \$5,000 to**
4 **provide legal representation to the Nation in connection with litigation and**
5 **negotiations related to the Central Arizona Project and such other matters assigned**
6 **by the Attorney General; and**

7 **WHEREAS, the Attorney General assigned certain legal matters to the Attorneys relating to**
8 **assistance in the preparation of an amicus curiae brief on behalf of the Nation in**
9 **support of the Petition for Special Action filed in the Arizona Supreme Court (No. CV-**
10 **04-0385-SA); and**

11 **WHEREAS, pursuant to Resolution 05-105, the Legislative Council approved the filing of the**
12 **amicus curiae brief; and**

13 **WHEREAS, additional funding is required to compensate the Attorneys for the legal**
14 **representation provided in connection with the preparation of the amicus curiae**
15 **brief; and**

16 **WHEREAS, the Attorney General has proposed Amendment No. 1 to the Attorney Contract which**
17 **increases the Contract amount from \$5,000 to \$10,000; and**

18 **WHEREAS, the budget of the Office of Attorney General (01-1031-810) has sufficient funds for the**
19 **increased Contract amount; and**

20 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval by the**
21 **Legislative Council of Amendment No. 1 to the Attorney Contract.**

22 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 23 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**
24 **Attorney Contract, in the form attached hereto, which increases the Contract**
25 **amount to \$10,000.**
- 26 **2. Funding for Amendment No. 1 shall be provided from the budget of the Office of**
27 **Attorney General (01-1031-810).**
- 28 **3. The Chairwoman of the Nation is authorized and directed to execute Amendment**
29 **No. 1.**
