

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-397, "Approving funding of the San Xavier Cooperative Association from the SAWRSA Trust Fund in the amount of \$348,965 for working capital needs of the San Xavier Cooperative Farm"; Approving the SXCA Budget Modification/ Amendment Request)

RESOLUTION NO. 05-214

1 **WHEREAS, the Tohono O'odham Legislative Council (TOLC) approved funding to the San Xavier**
2 **Cooperative Association (SXCA), from the Nation's SAWRSA Trust Fund in the amount**
3 **of \$348,965.00 (TOLC Resolution No. 04-397, August 18, 2004); and**

4 **WHEREAS, this funding provided for operational and capital needs for a six-month period from**
5 **October 1, 2004 through March 31, 2005; and**

6 **WHEREAS, the SXCA has identified deficits in the Salaries/Wages/Payroll Expense line item in**
7 **the amount of \$9,626.00 and has identified savings in the Farm Equipment and Farm**
8 **Operations line items; and**

9 **WHEREAS, the SXCA wishes to modify this budget to cover the deficits, and to request that the**
10 **leftover savings of \$14,159.58 in the Farm Equipment line item be utilized for vehicle**
11 **rental for use by Sales staff, and to purchase a seed/grain cleaner, which would**
12 **enable the SXCA to increase income and reduce labor costs; and**

13 **WHEREAS, the SXCA has submitted its request to the appropriate Legislative Committees,**
14 **Agriculture and Water Resources, which have reviewed the proposed modifications**
15 **and amendments.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **the budget modification to cover deficits in the Payroll Expense line item and**
18 **amendment request to use for vehicle rental, line item #613, and purchase of a**
19 **seed/grain cleaner, line item #700, for the San Xavier Cooperative Association,**
20 **herein attached.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the expenditure**
22 **of funds to September 30, 2005.**


23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD. Day**
24 **of MAY, 2005 at a meeting at which a quorum was present with a vote of 1,309.25 FOR; 1,235.3**
25 **AGAINST; 85.15 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


