4 **Tohono O'odham Legislative Council for approval; and**
5 **WHEREAS, during the May General Session the attached budgets were presented to the Tohono**
6 **O'odham Legislative Council.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**
8 **approves the budgets attached hereto, (District Administration and Community**
9 **Budgets) for the Districts Mining Royalties Distribution in the amount of \$54,789.14.**


10 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby incorporates**


