

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting May 20, 2005 Special Session to Address ICDBG Proposal for San Xavier District)

LEGISLATIVE ORDER NO. 05-220

1 **WHEREAS, Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation empowers**
2 **the Legislative Council "[T]o establish rules and procedures to regulate all meetings**
3 **of the Tohono O'odham Council, standing committees, boards, and special**
4 **committees"; and**


5 **WHEREAS, the San Xavier District has given notice to the Housing Committee of their intent to**
6 **submit a proposal to the Housing Urban Development (HUD) for FY '06, Indian**
7 **Community Development Block Grant (ICDBG); and**

8 **WHEREAS, the Housing Committee requests that a Special Session be held on May 20, 2005 to**
9 **address the ICDBG FY 06 Proposal for San Xavier District.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'Odham Legislative Council that it hereby**
11 **schedules a Special Session for May 20, 2005 to address San Xavier Districts' proposal**
12 **to the Housing Urban Development (HUD) for FY '06, Indian Community Development**
13 **Block Grant (ICDBG).**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 04TH Day of**
15 **MAY, 2005 at a meeting at which a quorum was present with a vote of 2,502.9 FOR; 126.80 AGAINST;**
16 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**
17 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
