

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2005 Budget)

RESOLUTION NO. 05-224

1 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 04-475, "Approving**
2 **San Lucy District to Continue District Operation – Pending Approval of the 2005 San**
3 **Lucy District Budget;" and**

4 **WHEREAS, the San Lucy District Council initially approved the FY 2005 district budget on**
5 **1 November 2004 and was desirous to have the budget approved in the December 2004**
6 **General Session of the Tohono O'odham Legislative Council; and**

7 **WHEREAS, a select group of community members petitioned the Legislative Council, not to**
8 **support the proposed FY 2005 district budget as prepared by the San Lucy District**
9 **Council, until the Council responds to questions and recommendations raised by**
10 **community members, whereby the Legislative Council directed the district to settle**
11 **differences prior to approval of the FY 2005 budget; and**

12 **WHEREAS, the San Lucy District Council and representatives for petitioners met on differences**
13 **thereby settling and agreeing to issues and concerns raised, resulting in a reduction**
14 **of the proposed FY 2005 budget from \$2,080,075.44 to \$1,972,121.03, a difference of**
15 **\$107,954.41; and**

16 **WHEREAS, the San Lucy District Finance Manager identified funds consisting of Gaming**
17 **Revenues in the amount of \$714,331.89, interest from P.L. 99-503 in the amount of**
18 **\$948,131.11, and other revenues in the amount of \$309,658.03 for a total of**
19 **\$1,972,121.03 to fund the FY 2005 San Lucy District budget; and**

20 **WHEREAS, the San Lucy District Council met on 1 April and approved the FY 2005 district budget.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **approves the San Lucy District FY 2005 budget in the amount of \$1,972,121.03.**

23 **BE IT FURTHER RESOLVED that revenues consisting of:**

24	Interest from P.L. 99-503 in the amount of	\$ 948,131.11
25	Gaming Revenues in the amount of	\$ 714,331.89
26	Other Revenues in the amount of	<u>\$ 309,658.03</u>
27	Total	\$ 1,972,121.03

28 **shall be the sources to fund the FY 2005 San Lucy District budget.**

29 **BE IT FURTHER RESOLVED that the San Lucy District FY 2005 budget shall be retroactive to**
30 **1 October 2004.**

1 **BE IT FINALLY RESOLVED** that by-weekly disbursement of P.L. 99-503 funds are wire transferred
2 to Stockmen Bank, Gila Bend Branch, Gila Bend, AZ – Account.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
4 of MAY, 2005 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0- AGAINST;
5 465.6 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1
6 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
7 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
9 Stat. 984).


