

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 and Proposed Budget of the Intergovernmental Agreement with Arizona Department of Health Services on Preparedness and Response for Bioterrorism)

RESOLUTION NO. 05-230

1 **WHEREAS, the Tohono O'odham Nation did by Resolution No. 04-265 enter into an**
2 **Intergovernmental Agreement with the Arizona Department of Health Services for**
3 **Preparedness and Response to Bioterrorism, Contract No. HG454313; and**

4 **WHEREAS, federal funds in the amount of \$260,192.00 are available to the Tohono O'odham**
5 **Nation through an Intergovernmental Agreement with the Arizona Department of**
6 **Health Services; and**

7 **WHEREAS, by Amendment No. 1, it was mutually agreed that the Intergovernmental Agreement**
8 **be extended to August 30, 2008 and the funding for grant year 2004 must be billed by**
9 **July 31, 2005; and**

10 **WHEREAS, the \$260,192.00 is included as a part of the Intergovernmental Agreement and**
11 **includes special provision that "The indirect costs shall not exceed 15% of the total**
12 **Personnel and ERE expenses"; and**

13 **WHEREAS, the Department of Human Services, Division of Community Health did submit to**
14 **reclassify title change of two internal position descriptions of Community Health**
15 **Assistant Manager and Tuberculosis Control/LPN to include duties and**
16 **responsibilities of preparedness and response to bioterrorism activities; and**

17 **WHEREAS, the Tohono O'odham Nation has negotiated provisions in the special terms and**
18 **condition of the Intergovernmental Agreement which preserve the Nation's sovereign**
19 **immunity from suit and restrict the application of state law on the Nation's**
20 **government; and**

21 **WHEREAS, this governmental agreement has been reviewed by the Health and Human Services**
22 **Committee and the Budget and Finance Committee, which recommend approval by**
23 **the Legislative Council.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
25 **Amendment No. 1 of the Intergovernmental Agreement with the Arizona Department**
26 **of Health Services, Contract No. HG454313, on Preparedness and Response for**
27 **Bioterrorism, and authorizes the Chairwoman of the Nation to execute the agreement**
28 **and any related documents reasonably necessary to receive and expend the**




