

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Legislative Branch FY 2005 Budget Amendment No. 2)

RESOLUTION NO. 05-231

1 **WHEREAS, the Legislative Branch FY 2005 Budget was approved by Resolution No. 04-650; and**
2 **WHEREAS, the Legislative Branch is requesting approval to transfer funds from its FY 2005**
3 **Salaries-610 line item to the Per Diem-640 line item, Capital-750 line item, and Public**
4 **Relations-812 line item to cover unanticipated costs through end of fiscal year 2005**
5 **as part of the proposed FY 2005 Legislative Branch Budget Amendment No. 2, which**
6 **is hereby incorporated by this reference; and**

7 **WHEREAS, the FY 2005 Legislative Branch Budget Amendment No. 2 also reflects a position**
8 **change (reclassification) from the Legal Assistant position to "Legislative Assistant"**
9 **and corresponding annual salary increase to \$45,000; and**

10 **WHEREAS, Budget Amendment No. 2 also incorporates FY 2005 Budget Surplus Revenue dollars**
11 **in the amount of \$136,915.14 to be transferred to the Capital-750 line item,**
12 **Professional Services - 810 line item, and Alterations and Renovations-778 line item**
13 **to cover unanticipated costs through end of fiscal year 2005; and**

14 **WHEREAS, the total amount of funds to be transferred for Budget Amendment No. 2 is**
15 **\$198,847.85; and**

16 **WHEREAS, this proposed amendment would increase the Tohono O'odham Legislative Branch**
17 **FY 2005 Budget to \$2,501,690.62 from \$2,364,775.48; and**

18 **WHEREAS, the Budget and Finance Committee on April 29, 2005 did review the proposed FY 2005**
19 **Legislative Branch Budget Amendment No. 2.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **approves:**

22 **1. The FY 2005 Legislative Branch Budget Amendment No. 2 and the resulting**
23 **increase in the Legislative Branch FY 2005 Budget to \$2,501,690.62 from**
24 **\$2,364,775.48.**

25 **2. The allocation of FY 2005 Budget Surplus Revenue dollars as a one-time funding**
26 **to the Legislative Branch in the amount of \$136,915.14 to the Capital-750 line item,**
27 **Professional Services-810 line item, and Alterations and Renovations-778 line**
28 **item to cover unanticipated costs through end of FY 2005 as set forth in Budget**
29 **Amendment No. 2.**

3. The reclassification of the Legislative Branch's Legal Assistant position to "Legislative Assistant" with a corresponding salary increase to \$45,000.00 per year.
